AUCTION SALE NOTICE



If the bid is accepted, the highest bidder shall deposit the full cost of the bid value on the same day and he is required to take delivery of the materials on the spot immediately.


The authority conducting the auction reserves the right to accept or reject any or all the bids without assigning any reasons thereof.




