Proceedings of the 6th Fee Structure Committee Meeting held on 14.08.2023 at 11.00 AM in the conference hall of State Council of Technical Education & Vocational Training, Bhubaneswar under the Chairmanship of Hon'ble Shri Justice B.N. Mahapatra regarding determination of fee in respect of Private Technical/Professional Educational Colleges and Private Diploma Institutions

The meeting of the Fee Structure Committee was held on 14.08.2023 at 11.00 AM in the Conference Hall of State Council of Technical Education & Vocational Training, Odisha, Bhubaneswar under the Chairmanship of Hon'ble Shri Justice B.N. Mahapatra. The list of members present in the meeting is attached at **Annexure-A**. At the outset, the DTE&T, Odisha & Member Secretary, FSC welcomed all members of the Committee and requested the Hon'ble Chairman, Fee Structure Committee (FSC) to conduct the meeting as per the Agenda. Thereafter, discussion was made on different agenda points and discussions in detailed made there on are as follows.

1. Confirmation of 5th proceeding of FSC meeting held on dtd.07.12.2022.

The proceedings of the 5th Fee Structure Committee (FSC) meeting was held on 07.12.2022 were confirmed.

2 Determination of fee structure in respect of Private Technical and Professional Colleges and Private Diploma institutions from the academic session 2023-24.

The recommendations made by the Sub-Committee in its meeting held on dtd.07.08.2023 & dtd.09.08.2023 for determination of fee structure from the Academic Session 2022-23 were discussed.

- Sri R.S. Sahoo, CA, Member of FSC, suggested that for determination of fee structure from the Academic Session 2023-24, the Covid year (2020-21) should be excluded while determining fee structure as the expenditure in Covid year was abnormally varied as compared to normal year. Mr. R. S. Sahoo, CA, FSC further said that though this was discussed in previous meeting the same does not find place in the proceeding. Hon'ble Chairman said that such guideline is there in Office

Memorandum dated 3.2.2022 issued by NMC. Mr. Sunil Kumar Sahoo, CA, FSC said that while calculating the Fee Structure of different institutions for the Academic year 2023-24, the expenditure of Covid year 2020-21 has not been taken into consideration.

- The suggestion of Director of Medical Education and Training, Odisha in Sub-Committee regarding determination of fee structure through grading process couldn't be discussed properly due to absence of him and the FSC decided to discuss it in next FSC Meeting. Further, the suggestion of DME&T, Odisha in Sub-Committee meeting regarding non implementation of revised fee structure retrospectively was accepted by FSC.
- Sri Sunil Kumar Sahoo, CA, Member of Fee Structure Committee brought to the notice of the Fee Structure Committee that examination of accounts furnished by the Institutions does not support the fee proposed by those Institutions. In some cases, the Fee proposed by Institutions is higher than the Fee calculated on the basis of their accounts following the guidelines of Fee Structure Committee Dated 29.08.2022. In some other cases, it is reverse. Mr. S.K. Sahoo, CA, FSC further brought to the notice of the Fee Structure Committee that the accounts furnished by the Institutions suffers from various defects. For example in some cases while the consolidated accounts of the Institutions has been signed by one CA, the segment accounts for different courses of the said Institutions have been signed by some other CA. Form 10-B prescribed under the Income Tax Act is required to be filed through e-filing mode, but the Institutions submitted manual Form 10-B before the Fee Structure Committee signed by CA and the said CA has not certified that Form 10-B submitted before the Fee Structure Committee is the True copy of Form 10-B filed through e-filing mode under the Income Tax Act. The Principal Secretary, Skill Development and Technical Education Department, Bhubaneswar suggested that one opportunity should be given to the Institutions to submit their reply to the defects noticed from their accounts before finalizing their Fee Structure. The Hon'ble Chairman, Fee Structure Committee suggested that in the interest of natural justice, the Institutions should be supplied with guidelines followed by the Fee Structure Committee for fixation of their Fee Structure if not earlier supplied and an opportunity should be given to Institutions to explain the defects noticed from examination of their accounts and to justify the fee proposed by them before finalizing Fee Structure of the Institutions. In this Context, the Committee unanimously decided to follow the suggestions given by the Principal Secretary and Hon'ble Chairman of Fee Structure Committee.

- After hearing from all the members of Fee Structure Committee (FSC), the FSC felt that as the Academic Session 2022-23 is already passed, it is not wise to determine fee structure retrospectively. In the present scenario, the FSC decided to determine fee structure from the Academic Session 2023-24 by hike of 7% of Consumer Price Index (CPI) over fee calculated from the Academic Session 2022-23. Accordingly, the Fee Structure Committee (FSC) recommended the following course wise fee structure given below to Government for approval with effect from Academic Session 2023-24.

2(h). The Fee Structure Committee accepted the suggestion of Fee Structure Subcommittee regarding fixation of ratio of expenditure for M.Sc which was fixed for MCA Course i.e. 1.5. According, the FSC recommended the following fee structure in respect of Silicon Institute of Technology, Bhubaneswar for approval of Government with effect from the Academic Session 2023-24.

2(i). The proposal of Sophitorium Engineering School, Baniatangi, Khurda was placed before Fee Structure Committee for determination of fee structure from the Academic Session 2023-24. As the said institute is a newly established institute and its Audited balance sheet is not available (being its first year), the Committee decided to fix its fee

structure at par with the fee structure of a nearby institute for the same course whose fee structure has been determined recently by FSC.

2(j). The Representation of DRIEMS Institute of Health Sciences and Hospital, Cuttack was placed before the FSC for determination of their fee structure from the Academic Session 2023-24. As, It is a newly established college, Sri R. S. Sahoo, CA, Member of FSC suggested that for determination fee structure of the said institutions, the actual cost of establishment of infrastructure to be taken into account and the same should be compared with most recently established institute for same course and which is lesser fee, may be finalised and his suggestions is in conformity with NMC Guidelines. The Hon'ble Chairman opined that the method suggested by Mr. R. S. Sahoo, CA, Member of FSC, i.e. actual cost of establishment infrastructure to be taken into account for determination of Fee Structure of newly established Institutions is not in conformity with NMC Guideline dated 3.2.2022. On the contrary in Paragraph-4 of the NMC Guideline, it is provided that in case of newly established medical colleges, the overheads like interest, depreciation and salary would be very high in comparison to old established colleges. There may be a case where no audited balance sheet would be available with the college (being its first year). In such a case, the determination of fee for a newly established college should be made on an ad-hoc basis, based on the fee structure of the most recently established medical college in the State, whose audited balance sheets is available.

Accordingly, for DRIEMS Institute of Health Sciences and Hospital, Cuttack, Government vide Notification No.4926/SDTE dtd.07.07.2023 has issued instruction regarding fee structure at par with Hi-Tech Medical College, Bhubaneswar which will be in force till further decision of FSC and the representation of the Dean and Principal, DRIEMS Institute of Health Sciences, Cuttack for re-consideration on the fixed fee structure will be taken into consideration in next FSC meeting once fee structure for Hi-Tech Medical College and Hospital, Bhubaneswar for the Academic Year 2022-23 will be finalised.

In the similar manner, the proposal of Sri Sri College of Ayurvedic Science and Research Hospital, Cuttack was placed before FSC. The Fee Structure Committee decided to fix its fee structure at par with the fee structure of a nearby institute for the same course in the state whose fee structure has been determined recently by FSC as it is a newly opened institute.

The Hon'ble Chairman, FSC further suggested that since Academic Year 2022-23 and 2023-24 has already been commenced and fees can't be implemented retrospectively the fee structure may be determined following the Guideline of FSC issued on dtd. 29.08.2022 or any other decision taken by FSC.

2(k). The Committee felt that the presence of an Educationalist in Technical field is mandatory while discussing the fee structure of different Technical Institutions. In this

regard, after retirement of Vice Chancellor (VC), BPUT from service, the new VC may be nominated by Chairman of FSC as an educational expert in Technical background. Further, the Committee decided for the coming Academic year (2024-25), Sri Sunil Kumar Sahoo, CA, FSC with one of the Expert in technical field should inspect the newly opened Institutions and other Institutions wherever necessary and submit their report which shall be taken into consideration for determination of Fee Structure.

2(l). Further, the calculated fee structure of the some institutions is very less as compared to their previous fee structure. In this connection, FSC suggested to ask the concerned institutes to give their justification as to how they are running their institutes with such a less expenditure and submit the reply within three (03) days or as earliest as possible. FSC may form a Committee comprising with educational experts to enquire into the matter and place the report before FSC for necessary decision. The list of institutions and their calculated fee are annexed at **Annexure-B**.

2(m). The Principal, Hi-Tech Medical College and Hospital, Bhubaneswar and Hi-Tech Medical College & Hospital, Rourkela were requested to produce Segment Audited income and expenditure report both for medical and college along with consolidated income and expenditure for the Financial Year 2021-22. It is noticed by FSC that the Segment income & Expenditure Account and Audited Report of the institute was signed by different Auditors which was not accepted. In this connection, the FSC decided to seek clarification from the concerned institute in the matter.

3. Determination of optional fee in favour of the above Institutions whose fee structure has been calculated.

The Fee Structure Committee recommended the same optional fees that was finalised in the last FSC meeting i.e. on 07.12.2022 from the Academic Session 2023-24 in favour of the above institutes whose fee has been finalised. The detailed optional fees are given below.

4. Non-determination of fee structure in respect of 78 institutions for non compliance of information/documents.

78 institutes didn't complied required information/data as sought for calculation of fee structure, as a result of which the fee structure of these institutions couldn't be revised from the Academic Session 2023-24. In this regard, FSC decided to issue show cause notice to the concerned institutes.

5. Proposal on single window entry with uniform fees into different UG & PG courses in Medical and Allied Health Science.

As per request of Government in Skill Development and Technical Education, Bhubaneswar, the proposal for formulation a guideline on collection of one-time University's registration and allied fees at the time of e-counselling by OJEE, DMET and Medical Counselling Committee for Odisha University of Health Sciences, Bhubaneswar from the Academic Session 2023-24 was placed before Fee Structure Committee. As the matter relates to process of collection of Registration fees from students, Government may take decision at their level and FSC has no role in the matter.

6. Representation of Technical and Professional colleges for retention of old fee structure.

The representation of Royal College of Pharmacy and Health Sciences, Berhampur, Temple City Institute of Technology & Engineering, Khorda and Biju Patnaik Institute of Information Technology & Management Studies, Bhubaneswar were placed before FSC for retention of old fee structure due to decrease in fee structure after revision from the Academic Session 2022-23.


Government in Skill Development and Technical Education Department, Bhubaneswar have constituted the Fee Structure Committee as per provision the provision of Orissa Professional Educational Institutions (regulation of admission and fixation of fee) act, 2007 for determination of fee for admission to the private professional educational institutions and sponsored institutions by taking into account of various factors as per provision in Section-7 of the OPEI Act, 2007 and the determined a fee does not amount to profiteering or exploitative in nature. FSC shall determine the fee structure of an institute taking into various factors so that determined fee does not amount to profiteering or exploitative and same shall be binding on such institution for a period of three years after Government approval.

In view of the above, the representations submitted by aforesaid institutions are disposed of being devoid of merit.

7. Discussion over determination of fee structure in respect of Deemed to be Universities.

The Fee Structure Committee may take steps for determination of fees of Deemed to be Universities as per Office Memorandum dated 3.2.2022 issued by NMC since the Order/Judgment of the Hon'ble Madras High Court dated 9.9.2022 passed in the Case of Education Promotions Society of India Vrs. Union of India

(WPC No. 10088 of 2022) and others has been stayed by the Hon'ble Supreme Court vide order dated 1.12.2022 in the case of National Medical Commission Vrs. Education Promotion Society & others in Special Leave to Appeal (See No. 20002-21009/2022 and other).


